"Thank you for your continued presence in our community!!"

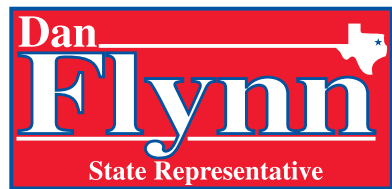
